Club Fees 2010/2011 & Schedule of Fees for Shooting activities  
Date: 6<sup>th</sup> June, 2010

Club Fees are due annually commencing 1<sup>st</sup> July, 2010 and covers members for a period of twelve (12) months. Prior to any shooting being undertaken by **FULL MEMBERS** your club fee structure needs to be complied with. Unless you are registered, you are not covered by Insurance; therefore you will be unable to compete in any activities at the club or external (tournaments), until registration is received. Members have fourteen (14) days from the 30<sup>th</sup> June to register their intention to re-join the club, or join for the first time – costs are detailed below:

**After fourteen days if you have not registered you will be ineligible to join in club activities**

**Seniors Full Members over 18 years of age: \$257.00 / year**

**Full Time University Students/  
Juniors U/18 & Pensioners (who draw a pension): \$227.00 / year**

**Cub U/12 archers: \$192.00 / year**

**Visitors Fee: \$20.00 per visit**

The above fee structure applies to those archers who have all their **own equipment** and do **not borrow any club equipment** (including arrows). If members borrow any part of the club equipment it will be at a cost of \$10 per session, plus all repairs must be completed before returning equipment to the club house.

This allows members to shoot, Saturdays, Sundays, School holidays, Public holidays and during daylight saving hours after 5.00p.m. week nights (Week night shooting may be restricted at times due to Soccer use of facilities, and will be advised to members). However, no U18 competitor is allowed to be shooting on the club premises without an adult being in attendance. Warringah Archers is a no-smoke zone.

**CONSENT FORM:**

By signing the Membership form provided, you are consenting to the disclosure of personal information to be published on Warringah Archers web site, newsletter and other publications.

**Note:** 1<sup>st</sup> installment is required to be paid prior to shooting, 2<sup>nd</sup> installment is required to be paid by 31<sup>st</sup> September 09 with the 3<sup>rd</sup> installment required to be paid by the 31<sup>st</sup> October, 2009. **A reminder will be sent to the individual 14 days prior.**

Pro-rata fees for new members apply after 3 months (30/9/10), dependant on date of when archer joins the club.
