Pro-rate Club Fees 2011/2012

Members have fourteen (14) days following completion of a beginner's course to join the club. This covers members until the 30th June following the joining period. Prior to any shooting being undertaken by **MEMBERS** the following fee structure needs to be complied with. Unless you are registered, you are not covered by Insurance; therefore you will be unable to compete in any activities at the club or external (tournaments), until registration is received.

1st October 2011 to 31st December, 2011

Seniors Full Members over 18 years of age:	\$213.00 / year
Full Time University Students & Pensioners (who draw a pension):	\$186.00 / year
Junior Members U/18	\$182.00 / year
Cub U/12 archers:	\$157.00 / year

1st January 2012 to 31st March, 2012

Seniors Full Members over 18 years of age:	\$153.00 / year
Full Time University Students & Pensioners (who draw a pension):	\$133.00 / year
Junior Members U/18:	\$131.00 / year
Cub U/12 archers:	\$116.00 / year

1st April 2012 to 30th June, 2012

Seniors Full Members over 18 years of age:	\$98.00 / year
Full Time University Students & Pensioners (who draw a pension):	\$90.00 / year
Juniors Member U/18:	\$88.00 / year
Cub U/12 archers:	\$77.00 / year

The above fee structure applies to those archers who have all their **own equipment** and do **not borrow any club equipment** (including arrows). If members borrow any part of the club equipment it will be at a cost of \$10 per session. All repairs must be completed before returning equipment to the club house.

Members can have access Saturdays / Sundays /School & Public holidays, and availability during daylight saving after 5.00pm week nights. (Week night shooting may be restricted at times due to Soccer use of facilities, and will be advised to members). However, no U18 competitor is allowed to shoot on club premises without an adult being in attendance. Warringah Archers is a no-smoke zone.
